**Key Points/ Agendas Discussed:**

1. Teams were established based on geographic areas to gather funds for the construction of the Temple & Heritage Centre building. These teams are directed to conduct fundraising campaigns door-to-door within their designated areas. Donor names will be updated and shared on the KKS website and WhatsApp groups.
2. A resolution previously passed in a prior executive body meeting regarding the naming of halls and acknowledgment for donations was unanimously passed again. The halls will be named for donations exceeding 10 lakhs, acknowledgment on an honorarium board for donations above 1 lakh, and on a dedicated wall for donations above 50,000. This resolution will now be submitted to the Registrar's office.
3. The Annual General Meeting (AGM) is set for 24th December 2023, from 3 pm to 6 pm at the Palam Vihar Community Centre. Preceding the AGM, a lunch party will be held from 1:30 pm to

2:30 pm. Notice of the AGM will be provided to the District Registrar's office next week and will also be uploaded on the KKS website by the General Secretary.

4. The President will send a reminder to Sh. R Wanchoo to recover the password and explore solutions for filing KKS's income tax returns.
5. A membership drive will be launched to engage active members and encourage increased community participation.
6. The organization's compliance with the new constitution of HR&RA 2012 necessitates updating details of KKS life members with Aadhar cards. Sh. Ramesh Kr Bhat Sr. has been entrusted with this responsibility, with full participation from other Executive Board members. The anticipated duration for this process is six to seven months.
7. The Temple committee has been tasked with commencing the tendering process and preparing the Bill of Quantities once the funds are amassed for the initial phase of Temple construction.
