The following points were discussed as per the agenda:

Receipt Books for Fund Collection

It was decided that all previously issued receipt books for fund collection will be recalled from members by the Treasurer & will stand null & void from today. These receipt books will be canceled and treated as obsolete. New receipt books will be issued in compliance with the 80G requirements today to all stakeholders & area representatives. The treasurer will keep the record with him regarding previous & present receipt books.

Corrections to Membership List

Several members raised concerns during the election process regarding missing names or discrepancies in their details on the membership list. The Executive Committee has resolved to initiate the necessary corrections at the earliest.

Updating life Membership Details

In order to facilitate the necessary corrections, life members will be asked to update their address details. Additionally, a push will be made for every member to obtain their KKS identity cards as it is mandatory as per Haryana society Act 2012, which will help automatically update the records, especially for members who joined before 2021. All 14 area representatives along with office bearers have been given the responsibility to connect with their area life members to correct the membership details & push to make KKS ID cards which will be must for next election voting & AGM voting. A resolution to this effect was passed uniamously that every life member of KKS has to make KKS ID card, as life members without KKS ID cards will not be allowed to participate & vote in next election.

Distribution of Membership List

The President has distributed hard copies of the membership list to individual constituency members. These members are tasked with ensuring that any necessary corrections are made within their constituencies along with KKS ID card formation.

Proposal for Wall of Fame

The President revisited the earlier proposal for a Wall of Fame. The resolution, which was passed, allows any member of the KP Baradari to contribute a donation (e.g., ₹50,000 to ₹1,00,000) and have the name of a family member (such as a parent) displayed on a dedicated wall. Anyone who pays above 1 lakh to 5 lakhs can display his parent name on the dedicated Hall of fame board. While anyone who can pay above 10 lakh will be able to name any one hall on his parents name without any rights on the property. This resolution was passed uniamously & will be uploaded on the District Registrar site for his information.

Mandatory KKS ID Card

It was confirmed that all KKS members are required to obtain an official KKS identity card, as per the organization's rules in compliance with HSA 2012. This initiative is to be promoted urgently.

Membership for Non-Members Who are major Donors

Sh. B.K. Raina proposed that any KP individual who has made a significant donation to KKS, but is not currently a member, should be offered membership as a courtesy and encouragement, regardless of whether they pay the membership fee. This proposal was discussed and is under consideration.

New Receipt Books for Constituency Members

The Treasurer has issued new receipt books for fund collection to all selected constituency members.

Issuance of Membership Fee Receipts

The Treasurer informed the committee that if a new member joins, no regular receipt books should be used to issue membership fee receipts. Instead, the Treasurer should be notified so that a separate membership receipt can be issued promptly to avoid confusion during record consolidation.

Proposal for Issuing Receipt Books to Opposition Members

A proposal was made to provide receipt books to Sh. R. Dhar and Sh. T.N. Kaul for fund collection as a gesture of goodwill, in order to avoid the isolation of the opposition team. This proposal is under discussion.

Co-opting of Members/Advisors

The President suggested co-opting certain members or advisors. The matter is under discussion, and the final selection will be notified to the Executive Committee in next executive meetings.
